#### RESOLUTION 2016-192

CASSELLHOLME

WHEREAS the Township of Papineau-Cameron, along with the Town of Mattawa, the Municipality of Calvin and the Municipality of Mattawan have clearly stated their request and intention to exit the Board of Management for Cassellholme in order to better serve the seniors in our local area;

AND WHEREAS it was understood that the target exit date would be December 30, 2014 and that all parties were working on an exit strategy to that end;

AND WHEREAS it appears that the finalization of an exit strategy has been stalled and the Township of Papineau-Cameron, along with the other three local municipalities, is still being levied by Cassellholme; AND WHEREAS Council resolution 2015-193 authorized the Clerk-Treasurer to hold payment of the 2015 Cassellholme levy until such time as an acceptable exit strategy has been negotiated and agreed upon by all parties;

AND WHEREAS the Lough Barnes Consulting Group has provided the Cassellholme Sub-Committee a report of a "Peer Review of the Cassellholme Strategic Review", that includes an exit strategy from the The Board of Management for the District of Nipissing East Home for the Aged - Cassellholme;

AND WHEREAS Council resolution 2016-191, the Council of Papineau-Cameron has supported the Lough Barnes Consulting Group's report and recommended exit strategy from the Board of Management for the District of Nipissing East Home for the Aged.

AND WHEREAS the Board of Management for the District of Nipissing East Home for the Aged (carrying on business as Cassellholme) has filed a legal statement of claim against the Corporation of the Township of Papineau-Cameron;

THAT Council is in agreement to pay Cassellholmes claim of \$53,799.00 which represents the 2015 Cassellholme levy, and that a copy of this resolution be sent to the Board of Management for the District of Nipissing East Home for the Aged – Cassellholme's solicitor Frank M. Falconi for settlement and dismissal of legal claim #CV16-6525-SR.
