MUNICIPAL DISASTER RECOVERY ASSISTANCE PROGRAM

WHEREAS a severe windstorm/downburst event occurred in the Township of Papineau-Cameron on June 21, 2025 which resulted in numerous downed trees and several washouts which blocked municipal roads; AND WHEREAS these conditions created hazardous travel situations, disrupted emergency service response capabilities and required significant unplanned use of municipal resources to clear debris and perform emergency repairs to municipal roads;

AND WHEREAS the costs of debris removal and washout repair were unexpected costs exceeding the Township's Operating Budget;

THAT Council is in agreement to submit an application to the Ministry of Municipal Affairs and Housing to request funding through the Municipal Disaster Recovery Assistance Program (MDRA) to assist with the costs incurred due to the severe windstorm/downburst event that went through The Township of Papineau-Cameron on June 21, 2025.
